Mr. Jones and Mr. Mysko attended the meeting to discuss the future long term care facility to be constructed in the RM of Meadow Lake and their current fund raising efforts. Mr. Jones explained that the RM of Meadow Lake and the City of Meadow lake are responsible for 20% of the cost of the facility. This facility will have a capacity of 72 beds for a total cost of \$40,000,000. The City and the RM agreed to split the share of \$10,000,000 equally. There is an account set up to help with expenses and they are open to any donations. So far, \$1,300,000 has been raised through donations as well as a special levy to the RM residents.

At present, the existing Pioneer Lodge is at capacity with waiting lists. The new facility will be a level 4 and 5 care and homecare will remain in the Pioneer Lodge once the new structure is up and running.
