## 2018 Municipal Election

Elections for councillors in even numbered Divisions (2, 4, 6) will be held October 24, 2018.

Nominations will be accepted from September 4th until 4:00 pm on September 19th.

Nomination forms can be picked up at the RM of Beaver River office.

- \*\*Just a reminder that voters who nominate a division councillor candidate must be from the division that the candidate is seeking office.
- \*\*Two signatures are required.
- \*\*The candidate must also sign the form.
- \*\*Elected members are elected for a four-year term.

Some important dates to remember are:

- September 19, 2018 Nomination Day
- October 24, 2018 Election day

#### **2018 Property Taxes**

The 2018 Property Taxes have been levied. Your copy should be arriving in your mailbox soon.

If there are multiple owners on your property title, every owner of the parcel will receive a tax notice with the TOTAL yearly taxes owing (unless you have arranged with the RM office to not have copies sent to all owners). It is the responsibility of the owners to decide who is paying the taxes or how the total will be divided up.

Council set a Mill Rate Factor of 0.50 for the Agricultural Class and the Residential class.

Council also set a Mill Rate Factor of 3.80 for the Commercial & Industrial class.

### **Electronic Payments**



When making your RM payments electronically <u>please ensure that we are aware of who the payment is for, especially when making a payment for someone else.</u>

When we get the an e-transfer we are only supplied with the amount and who the transfer is from. Sometimes this name does not match any of our records and we do not know what property to credit with the payment. Please send us an email or phone us with the roll number or name that appears on our records.

Interest could be incurred if we cannot apply the payment in time.

As of January 1, 2019 e-transfers will no

longer be accepted as a method of payment at the RM as well as the Lac des Iles Utility Commission. This change is a result of our Auditor's recommendation and is for your individual protection as an e-transfer can be deposited to any bank account.
