**Electronic Payments**



When making your RM payments electronically please ensure that we are aware of who the payment is for, especially when making a payment for someone else.

When we get the an e-transfer we are only supplied with the amount and who the transfer is from. Sometimes this name does not match any of our records and we do not know what property to credit with the payment. Please send us an email or phone us with the roll number or name that appears on our records.

Interest could be incurred if we cannot apply the payment in time.

**As of January 1, 2019 e-transfers will no longer be accepted as a method of payment at the RM as well as the Lac des Iles Utility Commission. This change is a result of our Auditor's recommendation and is for your individual protection as an e-transfer can be deposited to any bank account.**
