A BYLAW TO PROVIDE FOR THE CLOSING OF A MUNICIPAL ROAD.


The Council of the Rural Municipality of Beaver River No. 622 of Pierceland, in the Province of Saskatchewan, enacts as follows:

1. Subject to the consent of the Department of Highways and Transportation, the Municipality agrees to close the municipal road described as:

The road running between the Rural Municipality of Beaver River No. 622 and the Rural Municipality of Loon Lake No. 561 west from Highway 21 south of or through the following legal descriptions and shown on the attached Schedule "A".

RM No. 622 – SE & SW 4, SW 5, SE & SW 6 –59-25 W3; SE & SW 2-59-26 W3.

RM No. 561 – NW 32, NE & NW 31-58-25 W3; NE & NW, NE, NW 35, NE & NW 36-58-26 W3.

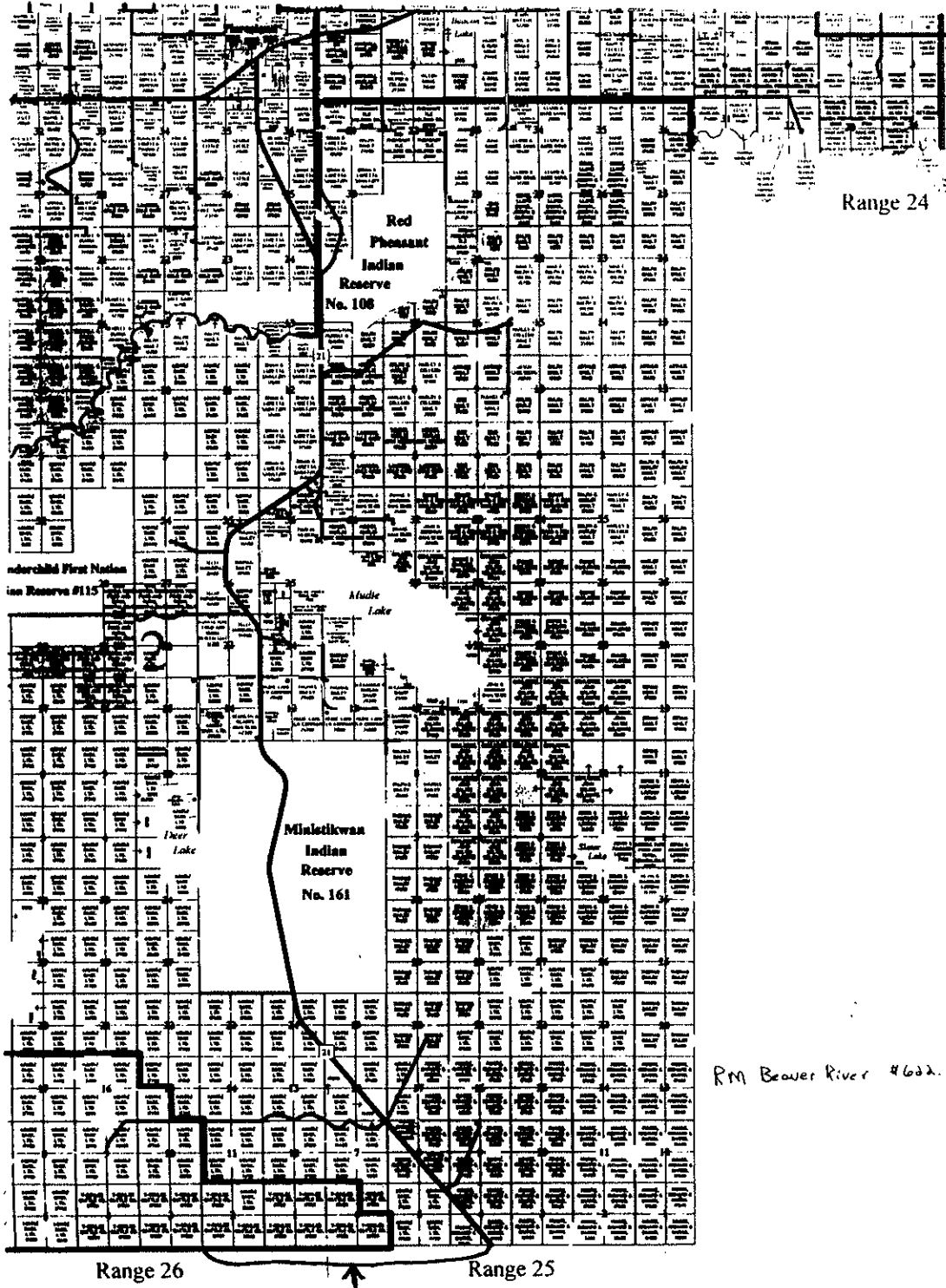

- b) to close the following:


