PIERCELAND MAINTENANCE SHOP TENDER, 2019

The RM of Beaver River No. 622 hereby invites tenders from qualified contractors in order to award a contract for the following:

- Construction of a 50' x 70' Commercial Steel Frame Building at 123 Main Street, Pierceland, Saskatchewan. Proposed building shall be constructed adjacent to the existing maintenance shop.

Building Specs:

- 50' x 70' – 18' Commercial Steel Frame Building.
- Mono Slope 1:12 roof pitch / standard roof (please include price quotations for BOTH options).
- Stamped engineered drawings to be provided.
- WMP-50 6" Faced insulation – Roof and walls.
- Exterior building wrap behind wall metal.
- Two 20' x 16' Commercial overhead doors with openers.
- Two 3' x 6'8" outward swing walk-in insulated commercial doors.

Concrete Slab (to be quoted separately & awarded separately if necessary):

- 50' x 70' - 6" concrete pad with frost wall.
- High strength concrete.
- 10mm rebar 16" o/c in both directions.

The Contractor shall furnish all labour, equipment and material to perform the work as specified herein.
