A quorum being present, Reeve Rolfes, called the meeting to order at 8:30 AM.

RM Maintenance Supervisor Mike Coolidge Joined the meeting at 8:30 AM.

189-19 Agenda **Degenhardt:** That the following items be added to the June 26, 2019 meeting agenda:

- Recycled asphalt application

190-19 Recycled Asphalt **Kruchkowski:** That should any RM ratepayers be interested in personally applying, at their own expense, recycled asphalt to municipal roads adjacent to their property, they be granted permission to do so on the condition that the RM is notified prior to application date, giving sufficient time to coordinate with the RM grader schedule.

Council discussed the 2019 gravel allocations to be distributed to each Councilors division. Gravel maps for each division were submitted to the Administrator. Program start date remains to be determined and is subject to municipal roads moisture content.

Mike Coolidge excused himself from the meeting at 9:35 AM.

Nick Stoebich joined the meeting at 9:49 AM.

**Delegation #1 (Nick Stoebich – RM Property Owner PT SW-06-63-22-W3) – 10:00 AM**

In October 2008, the RM agreed to obtain a water sample once yearly from the residence located on the above mentioned property. Should the water supply be negatively impacted, the RM agreed to drill a new well or install a cistern with a sufficient supply of water at RM expense.

On May 22, 2019, an Environmental Services Analysis Report disclosed negative test results of Mr. Stoebich's drinking water. Council requested that Mr. Stoebich attend the meeting to express his concerns and remedial expectations regarding his personal domestic well on his property.

Mr. Stoebich stated that he would find it acceptable for the RM to drill a new water well. The new well should be located on higher ground so as to avoid any future ground water runoff and be drilled deep enough so as to access an alternative aquifer. Mr. Stoebich asked that the RM be responsible for trenching a line from the new well to his residence and perform testing to ensure that the new water is acceptable for human consumption.

RM Council stated that they are agreeable to hire a contractor for well drilling and trenching as well as testing of the new water, however, should the water be deemed safe for human consumption and contain amounts of iron etc., the optional treatment of the water be the sole responsibility of Mr. Stoebich.

Nick Stoebich excused himself from the meeting at 10:11 AM.
