Mike attended the meeting to discuss various maintenance plans and ongoing projects in the RM.


<u>Delegation #2 (Barry, Glenda and Ron Getzinger – RM Ratepayers) – 9:24 AM</u>

Delegation #4 (Tal & Marla L'Heureux - RM Ratepayers) - 10:27 AM

Councilor Rewega joined the meeting at 10:27 AM.

Tal and Marla approached Council to discuss the property classification on PT NE-35-61-26-W3. Tal explained that he had forwarded a letter in March 2019 for Council consideration requesting that the property classification on the above mentioned property be changed from commercial to agricultural. At their regular meeting on April 18, Council discussed this request and made a resolution advising Tal to follow the appeal process to ensure that SAMA (Saskatchewan Assessment Management Agency) visit the property to re-assess the property classification. The Municipality was informed that SAMA will no longer offer any ruling on property classification.

Tal expressed his frustration with the Board of Revisions decision to deny his appeal. He stated that no commercial activity has taken place on the property in 2019. He explained that the property is currently owned by Canadian Arrow Oilfield Services Ltd. and will be acquired by Mudie Lake Elk Company as at October 31st, 2019. Tal asked that Council consider abating the current 2019 commercial property taxes to reflect agricultural rates.

Delegation #6 (Neil Degenhardt – RM Ratepayer) – 11:29 AM

On September 30th, 2019 a letter was forwarded to Neil stating that Council had become aware of unauthorized road construction on a municipal road allowance. The deficiencies were listed along with instruction to remedy within 180 days.

Neil approached Council to discuss the road he constructed on the municipal road allowance located between SE-03-62-24-W3 and SW-02-62-24-W3. Neil explained that he was authorized by a member of Council to perform brushing, ditching and culvert installation along the road allowance. All work was performed at no cost to the RM and for the purpose of providing Ron Getzinger with access to his adjacent farmland. He stated that the road in question is approximately 23" outside the road allowance boundaries for a distance of roughly 200 – 300 feet.

Neil proposed that Council consider the expropriation of 1.5-2 acres of land to the west of the road allowance that piles of brush currently sit on. The RM could then burn the brush and Neil would agree to bury it. Should Council disagree, Neil proposed that payment for all brushing he has performed along this site to date be paid (approximately \$7,000.00). In the case that no agreement is made with Council on the matter, a settlement may be reached through the Courts.

Council thanked Neil for attending and he excused himself from the meeting at 12:20 PM.
