Public Notice – Zoning Bylaw Amendment

Public Notice is hereby given that the Council of the Rural Municipality of Beaver River no. 622 (RM) intends to adopt a bylaw under *The Planning and Development Act, 2007*. A bylaw to amend Bylaw No. 9¹ known as the Zoning Bylaw (ZB).

INTENT: The proposed amendment would outline a system to address offences and penalties related to contravention of the ZB.

AFFECTED LAND: All lands within the RM would be affected by the proposed amendment.

REASON: The new provisions for offences and penalties are desired by Council to provide a system to encourage bylaw compliance.

PUBLIC INSPECTION: Any person may inspect the bylaw at the RM Office during regular business hours, excluding statutory holidays. Copies will be available to the public at a cost or by contacting the Development Officer (yvonne@northboundplanning.ca; (306) 397-1000 and asking for a copy.

PUBLIC HEARING: Council will hold a public hearing at **11:00 AM on March 19, 2020**, to hear any person or group that wants to comment on the proposed bylaws. Council will also consider written comments received **on or before March 16, 2020**, by the undersigned at the RM office by hardcopy or email before the hearing. The RM office is located at 159 Main Street, Pierceland, SK, S0M 2K0.

Do you own or lease land in an adjoining municipality?

(RM of Meadow Lake #588 or RM of Loon Lake #561)

If so, you are eligible to receive a municipal tax exemption on your permanent residential dwelling
as per section 293 of The Municipalities Act.

You must fill out the prescribed form called the "Land Owned or Under Lease Agreement in
Adjoining Municipalities". It must be completed with the other RM Administrator's Authorization
Signature. You must return the form to the RM of Beaver River's office on or before **March 31st**
ANNUALLY to be eligible for this exemption.

Employment Opportunity – Weed Sprayer

The [Weed Control Act](#) is provincial legislation that empowers municipalities to enforce the control of prohibited, noxious and nuisance weeds by land owners within the boundaries of the municipality.

The role of the Weed Sprayer is to complete weed management in the municipality ensuring that all prohibited and noxious weeds are controlled, and that no uncontrolled infestations remain.

The Weed Sprayer will have knowledge of the Weed Control Act, education in or knowledge in plant identification, crop production and horticulture. He/She must have an understanding of modern agricultural production practices. A Pesticide Applicators Certificate will be required. The employee shall, while on the job, take a reasonable care to protect the health and welfare of themselves and others on the worksite. The Weed Sprayer shall possess spray equipment, and be responsible for vegetation control within municipal boundaries on roadside right-of-ways, municipal gravel pits, and/or other areas as assigned. He/She is responsible for operating and maintaining vehicle, spraying equipment and machinery. You will perform other related duties as required.

Application must include rates of remuneration as well as an equipment listing. You will be required to show proof of all applicable training courses, liability insurance and WCB coverage.

A valid Class 5 driver's license is required. The applicant must have the ability to perform physical labour as part of the job duties and stand/walk for extended periods of time. You must be able to work alone, under minimal supervision and have a safe and responsible attitude in dealing with all equipment and tools. You must possess good verbal communication skills.
