### Upcoming Hail Deadlines

June 15: Last day to file crop reports

June 30: Last day for new applicants to apply for coverage with SMHI



If you did not withdraw from the SMHI hail program as at March 31, 2020 you are required to file your crop report on or before June 15th, 2020. Failure to do so may result in an appointed official completing a certified crop report on your behalf for a fee.



### Visitors to the Lakeshore Subdivisions

As per RM Bylaw 2-14:

"A second temporary motor home or trailer home will be allowed as a visitor to the site for a period of no more than 21 consecutive days within a calendar year."

### Burn Permits

Burn permits are required **April 1 to October 31**.

1. No burning of any material shall be allowed within the boundaries of the Municipality from April 1 to October 31, without the prior obtainment of a burning permit. Failure to obtain a permit could result in a fire department callout and monetary charges to the landowner.
2. The permit shall be issued from the RM office free of charge.
3. The RM retains the right to refuse to issue or cancel burning permit if council feels that conditions are not suitable to burn.
4. The following condition shall be indicated on permit: "The landowner is totally responsible for the fire until it is completely extinguished."
5. If the burn location is within 3 miles/4.5 km of the Meadow Lake Park, a parks permit also needs to be obtained by calling 306-236-7696.

**Council may at any time impose a fire ban.**



### Managing Stress

There are ways of dealing with stress and we can learn to recognize and manage it. Some positives steps to take:

- Exercise
- Eat a balanced diet
- Take time for yourself
- Avoid alcohol and drugs
- Don't isolate yourself
- Separate those things you can control from those that are beyond your control
- Deal with problems - avoidance only complicates them
- Focus on solutions rather than dwelling on the negatives
- Base decisions on accurate information
- Set priorities and proceed step-by-step. Don't try and solve everything at once
- Talk to others - Often by talking to a trusted person, you can gain a perspective that may lead to practical solutions. You may come up with alternatives that you have not considered.
