Meadow Lake Provincial Park Entry Permits At Boat Launches

Meadow Lake Provincial Park now requires **Park Entry Permits** at Lauman's Landing boat launch and The Shore's West boat launch. Signage was placed by Meadow Lake Provincial Park on Wednesday, June 30, 2021. These parcels are leased by the RM from Meadow Lake Provincial Park.

This is not a new requirement, it is the first year that it is being posted and enforced at these locations.

Park entry (Park Entry Permit) is required year round and is charged on a per vehicle basis and must be paid for and displayed in order to access any Saskatchewan Provincial Park. A valid Park Permit purchased at one Saskatchewan Provincial Park is valid at all Saskatchewan Provincial Parks.

MLPP has informed the RM that they will be enforcing the requirements of park entry permits at both of these boat launches.

- your personal information is kept private (including during access requests)

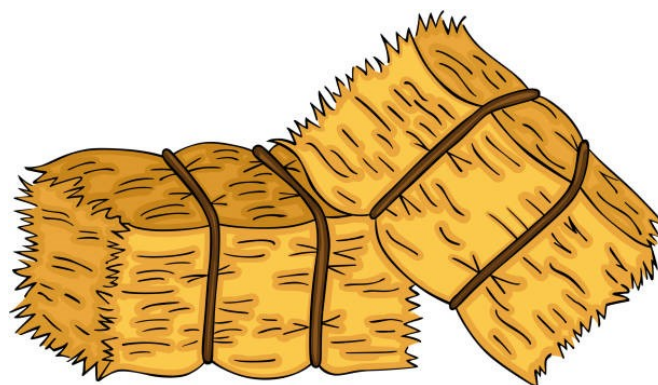

Hay Salvage in Ditches

The hay salvage provides:

- free hay to farmers
- a neat appearance
- improved visibility
- better control of brush and harmful weed growth
- snow storage in ditches during the winter months



Hay Salvage

Hay can be salvaged any time during the spring or summer months.

Hay must be cut at a uniform height in ditches. Bales must be placed at least eight metres away from the shoulder of the highway.

As safety is the number one priority, the Ministry of Highways may remove and dispose of hay bales if locations are deemed unsafe for drivers.

Participant should contact their local ministry office to provide contact information and limits on where they are salvaging hay. This will help to avoid disputes and better coordinate with other activities that may be happening within the highway ditch, including ditch mowing by contractors and others.

Key dates for hay salvage

July 8: Prior to and including this date, a landowner or lessee nearest to a highway ditch has the first opportunity to cut or bale hay.

After July 8: Cut and bale hay on a first come, first serve basis. The nearest landowner's permission is not required after this date. Cutting and baling hay should not be initiated if the mowing contractor is mowing near the area.

August 8: All hay bales must be removed from ditches or they may be removed and disposed of

They gained their name as “dog days” as they were connected with the star Sirius, which is part of the Canis Major (Greater Dog) star system. Nowadays, “the dog days” refers to when the hottest days of summer begin.
