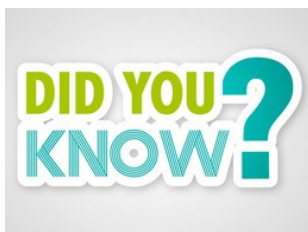

That Camping Trailers and RV's placed as a principal dwelling in the lakeshore subdivisions must have a Development Permit submitted and approved.

The stay for guests with camping trailers or RV's in the lakeshore subdivisions is a maximum of 21 consecutive days.

Recreational Property Maintenance Tender

Lac Des Iles Washrooms and Fish Filleting Shacks (Weekends/Holidays ONLY)

This tender is to supply the following maintenance services for the RM of Beaver River No. 622 every Saturday, Sunday and all statutory holidays (Friday and Monday holidays only) for the period commencing on May 21, 2022 to September 5, 2022 inclusive.

RM West Boat Launch (NE 12-63-23-W3) / RM East Boat Launch (SE 17-63-22-W3):

Washrooms

- must be cleaned and bleached daily
- empty and remove garbage daily (haul to RM waste collection site)
- refill paper products as required
- cleaning products and paper products will be supplied by RM
- monitor septic tank daily and notify RM when pump out is necessary

Fish Filleting Shack

- must be cleaned and bleached daily
- cleaning supplies will be supplied by the RM
- empty and remove garbage daily (haul to RM waste collection site)
- remove and haul away fish offal daily to RM waste collection site
- remove garbage or anything that is not fish offal before disposing in designated area.
- monitor septic tank daily and notify RM when pump out is necessary

Miscellaneous

- RM will be responsible for the winterizing of plumbing and buildings, etc.
- report any required repairs and potential hazards to the RM office

The Shores MR1 Park:

Washrooms

- must be cleaned and bleached daily
- empty and remove garbage daily (haul to RM waste collection site)
- refill paper products as required
- cleaning products and paper products will be supplied by RM
- monitor septic tank daily and notify RM when pump out is necessary

Miscellaneous

- RM will be responsible for the winterizing of plumbing and buildings, etc.
- report any required repairs and potential hazards to the RM office

OTHER TENDER DETAILS

The official tender document (available under Tenders on www.rmofbeaverriver622.ca) must be filled out for tender submission to be considered valid.

The contractor shall be responsible to supply and pay all associated costs of employees or labor to complete work indicated above.

The RM pays all costs associated with Worker's Compensation Board.

The contractor shall obtain liability insurance in the amount of \$2,000,000 (Two million dollars) and shall supply the RM with a copy of liability insurance upon awarding of the tender.

Tender payment shall be paid in four equal installments (in correspondence with Council meetings) due on the following dates: June 16, July 21, August 18 and September 15, 2022.

Tender closing date: May 5, 2022 4:00 p.m. CST

LOWEST or not necessarily any tender accepted.

Terms and conditions (including commencement date) are subject to change due to the current COVID pandemic.

The RM of Beaver River No. 622 retains the right to reject ALL tenders.

Burn Permits:

Burn permits are issued by the Municipal Office at NO FEE.

From April 1st to October 31st annually, no person shall light or cause to be lit any fire, or permit any fire to be lit upon land that the person owns, occupies or controls, unless the person holds a valid and subsisting Burn Permit (Schedule B) or the fire is exempt from the requirement for a Burn Permit under this policy.

The following items are exempt from the requirement for a Burn Permit:

Solid fuel barbeques
Liquid fuel barbeques
Recreational camp fires
Fireworks

Any person(s) wishing to burn on land located within three (3) miles of the Provincial Park boundary shall be required to obtain a Burn Permit from BOTH the Municipality and local Saskatchewan Environment Office.

In the event that the Provincial Park has implemented a Fire Ban, no RM Burning Permits shall be issued for any/all land located within 3 miles of the Park boundary. The 3 mile Park boundary is indicated on RM map.

A Burn Permit expires after such time as seven (7) days from the date noted on the permit.

An application for a Burn Permit shall be submitted to the Municipal Office for their approval, using the prescribed form (Schedule B).

A Burn Permit is not transferrable from one person to another or from one location to another.

Council may suspend or revoke a Burn Permit, if, in the opinion of Council, acting reasonably:

The holder of the Burn Permit has contravened this policy, The Wildfire Act, applicable legislation or the terms and conditions of the Burn Permit; or

The suspension or revocation of the Burn Permit is necessary or desirable for the protection of persons or property.

Upon receiving notification of the suspension or cancellation of a Burn Permit, the holder of the Burn Permit shall immediately extinguish any fire set pursuant to the Burn Permit.

It is the sole responsibility of every person who sets a fire under the authority of a Burn Permit to keep a copy of the Burn Permit at the site of the fire.

Every person who sets a fire under the authority of a Burn Permit shall:

Produce the Burn Permit to a Fire Department Member or Enforcement Officer upon demand; and

Ensure that the fire is supervised, at all times, by a responsible adult, until the fire is fully extinguished.

A person to whom a Burn Permit has been issued, and any person involved in the lighting, supervision or maintenance of a fire set pursuant to a Burn Permit, shall comply with all terms and conditions of the Burn Permit.

“Fire Permit Area” sandwich board signage is available at the Municipal Office for any person(s) to whom a Burn Permit has been issued. All signage shall be returned to the Municipal Office after expiration of the Burn Permit undamaged and in a timely fashion.
