Be Bear Aware



Spring is in the air and the Ministry of Environment is reminding residents to be bear aware.

The warmer weather means that bears are leaving their dens to search for food and there's a greater chance that you may encounter one.

Black bears are found throughout the province. Their range includes all northern Saskatchewan forests and extends southward into the aspen parkland. Bears can be found in many other areas where suitable habitat exists including the Touchwood Hills, the Qu'Appelle Valley and the South Saskatchewan River Valley.

"We share our province with wildlife," Environment Minister Warren Kaeding said. "Keeping your yard free of attractants is the best way to avoid a bear encounter. Bears are smart animals; if they can't find food, they will leave the area."

When bears associate humans with their food source, they become a nuisance and a threat to public safety. New regulations prohibit the feeding of bears, wolves, cougars and coyotes, even on the side of the road. This regulation is designed to address concerns related to dangerous wildlife gaining access to human-sourced foods.

If you live, work or spend time in bear country, take precautions with attractants - including household waste.

Here is what you can do to prevent a safety risk for yourself, your community and bears:

- Store garbage in a secure building or buy a bear-resistant container. Only put the bin out on the morning of collection.
- Wash all recycling items and regularly clean garbage or recycling bins.
- ♦ Avoid leaving pet food accessible to wildlife.
- Only use bird feeders in the winter when bears are hibernating.
- ♦ Do not add fish, meat, fat, oils, unrinsed eggshells or any cooked food to backyard compost bins.
- Thoroughly clean and store barbecue grills after each use.



Hummingbirds

You probably think the poor hummingbird never rests. Wrong. They spend 75 to 80 per cent of the day just perching. They are able to enter a state of torpor, where their metabolism slows down their hearts to 50 to 80



beats per second. Their kidney function slows down correspondingly. However, when they do get up and go, they are a picture of energy, beating their wings 20 to 30 times per second, which uses up a lot of nectar and bugs and spiders. They cannot walk or hop but can move sideways on their four-toed feet.

They have a voice.

It's not raucous, but it is a voice. Hummingbirds have a one-note chirping sound that is called a chip note. They also use their wings and tails to make sound and communicate. If you hear a clicking sound, it could be two males dueling over a female with their beaks. They will not hesitate to attack crows, hawks or jays that they feel are impinging on their territory.

Vigilance for bird flu.

So many Canadians love watching hummingbirds and this year there are many questions about whether it is safe to leave feeders out for our feathered friends. The news changes steadily, but as of May 12, 2022, Environment and Climate Change Canada recommends not feeding wild birds by hand or if you are in an area with domestic poultry. This means you can keep your hummingbird feeders (unless you live on or near a farm), but you should clean them every two weeks with bleach. Watch the news for updates.

Help Young Wild Animals by Leaving Them Alone

The Ministry of Environment has a simple message for well-meaning people who want to rescue what appear to be orphaned young animals: please don't touch them.

Many animals leave their young alone for long periods while they forage for food, or to protect them from predators. During these times, the young can be vulnerable to children, pets, or even well-intentioned adults.

While "saving" the animal may seem like the right thing to do, contact with humans can significantly decrease a young animal's chances for survival.



In most cases, young animals are not abandoned at all - the mother is often nearby and sometimes even watching.

There can be hazards for humans, too. Wildlife can carry infectious diseases that can be transmitted to people, including rabies and West Nile virus. It's also illegal to take wild animals home. Only recognized wildlife rehabilitators are licensed to care for orphaned and injured animals, as they have the expertise to provide appropriate care. This will give the animals the best chance when they are released back into the wild.

A young animal should only be picked up if the parent is found dead nearby, or if the animal is found in an unnatural situation, such as a baby bird on a doorstep. In that case, you can move the young bird to the closest suitable habitat.

A basic rule to follow is this: unless you believe they are in immediate danger, always call for advice before removing young animals from the wild.

For instance, before concluding that a deer fawn is abandoned, ask yourself:

- Has it been lying in the same position for more than 10 hours?
- Is it vocal?
- Is it covered in insects?
- Is it wet, possibly covered by the morning dew?

If the answer to any of these is yes, the animal may have been there a while and needs help.

If you can see obvious signs of injury or evidence that the animal has been orphaned, please contact your local conservation officer.

Remember to give wildlife - of all ages - space and respect.
