The RM of Beaver River can be contracted to snow plow your rural driveway with a grader. Prepaid snow plow flags are available at the RM office for \$40 plus GST. A form must also be filled out authorizing the RM to complete this work. The form is available both at the RM office and on the website under Policies & Bylaws, then click on RM Forms. If you purchase a flag and place it at your driveway entrance the work will be done when the grader is in your area.

#### **RURAL MUNICIPALITY OF BEAVER RIVER NO. 622**

#### Public Notice -Basic Planning Statement and Zoning Bylaw Amendments

Public Notice is hereby given that the Council of the Rural Municipality of Beaver River No. 622 (RM) intends to adopt a bylaw under *The Planning and Development Act, 8663*. A bylaw to amend Bylaw No. 58 known as the Basic Planning Statement (BPS), and a bylaw to amend Bylaw No. 57 known as the Zoning Bylaw (ZB).

**INTENT:** The proposed BPS amendment would provide additional policy guidance for consideration of small agricultural parcels (under 14 ha; 34.6 ac) in the **A-Agricultural District**.

The proposed ZB amendment would allow, at the discretion of Council and subject to BPS policy, and evaluative criteria, agricultural parcels in the **A-District** to a minimum of 4.86 ha (12 ac) per parcel and up to 4 parcels not exceeding a total area of 24.28 ha (60 ac), and where at least 32.4 ha (80 ac) remain unsubdivided within the balance of the agricultural holding. The landowner would be responsible for any upgraded road access, and residential development would be expressly prohibited without a change to a principal residential land use along with the appropriate permitting, municipal and provincial requirements having been met.

**AFFECTED LAND:** Lands within the **A-District** would be affected by the proposed bylaws.

**REASON:** The proposed amendments would allow for agricultural parcels smaller than currently allowable subject to conditions deemed appropriate by Council by bylaw, and where residential development is not intended or permitted.

**PUBLIC INSPECTION:** Any person may inspect the bylaws at the RM Office during regular business hours, excluding statutory holidays. Hard copies will be available to the public at a cost or by contacting the Development Officer (ceo@northboundplanning.ca; (306) 397-1000) and asking for a digital copy.

**PUBLIC HEARING:** Council will hold a public hearing at **11:00AM** on **December 15th, 2022,** to hear any person or group that wants to comment on the proposed bylaws. Council will also consider written comments received **on or before December 12th, 2022,** by the undersigned at the RM office by hardcopy or email before the hearing. # Investing in Canada Infrastructure Program Funding

On October 6, 2022, Canada and Saskatchewan announced more than \$44.6 million in federal-provincial funding for 28 new infrastructure projects across Saskatchewan. The RM of Beaver River along with the Village of Pierceland is receiving funding for the Pierceland Landfill Decommissioning Project under the Investing in Canada Infrastructure Program.

Decommissioning and reclaiming of the former landfill, including three primary, former waste disposal areas, historically operated by the Village of Pierceland and the RM of Beaver River No. 622:

Federal Funding: \$575 122

Provincial Funding: \$479 220

RM and Village Funding: \$383 463

It only takes four simple steps to become better prepared to face an emergency:

- 1. Know the risks
- 2. Make a plan
- 3. Get or prepare an emergency kit
- 4. Download SaskAlert to receive alerts of emergencies happening now in your location www.saskalert.ca

#### **Build a Kit**

Your emergency kit should have everything you, your family and your pets would need to be safe and take care of yourselves for at least three days immediately following an emergency. Your kit should be portable in case you need to evacuate.

#### **Family Essentials**

food (non-perishable and easy-to-prepare items, enough for three days) and a manual can opener bottled water (four litres per person for each day)

medication(s)

flashlight

radio (crank or battery-run)

extra batteries

first-aid kit

candles and matches/lighter

hand sanitizer or moist towelettes

important papers (identification, contact lists, copies of prescriptions, etc.)

extra car keys and cash

whistle (to attract attention, if needed)

zip-lock bag (to keep things dry)

garbage bags

#### **Extra Supplies for Evacuation**

clothes, shoes

sleeping bags or blankets

personal items (soap, toothpaste, shampoo, comb, other toiletries)

playing cards, travel games, other activities for children

#### **Special Considerations**

items for babies and small children – diapers, formula, bottles, baby food, comfort items

prescription medication

medical supplies and equipment

any other items specific to your family's needs

#### **Pet Essentials**

Food and water: A seven day supply of food and drinking water in an airtight, waterproof container.

Current photos of you and your pet, important documents, medications, medical record, extra supply of the medicines your pet takes on a regular basis in a waterproof container, pet first aid kit, collar/harness, ID Tag and leash, crate or other pet carrier, sanitation: Include pet litter, a litter box, paper towels, plastic trash bags and a container of household bleach to provide for pet sanitation.

#### 1. Coca-Cola made 'A Charlie Brown Christmas' possible.

TV producer Lee Mendelson first pitched a documentary about Charles Schulz's comic strip Peanuts to different networks, but not one bit. Finally, he got some good news: The Coca-Cola Company wanted a Schulz holiday special. "The bad news is that today is Wednesday, and they'll need an outline in Atlanta by Monday," the ad agency told Lee. Scrapping their original plans, Lee and Charles quickly prepped an overview in less than one day, describing "winter scenes, a

school play, a scene to be read from the Bible and a sound track combining jazz and traditional music." Coca-Cola agreed to the plan — but gave the team only six month to bring the project to life.

Producers picked slightly off-key music for 'A Charlie Brown Christmas' on purpose. Soundtrack standouts "Christmas Time Is Here" and "Hark! The Herald Angels Sing" both feature real children singing. The choir director wanted perfection from his pint-sized musicians, but Lee and composer Vince Guaraldi wanted "kids to sound like kids." The final cut includes a slightly off-key version of "Hark! The Herald Angels Sing" for that reason.

#### 2. Dr. Seuss's widow would only let certain actors play the Grinch.

Audrey Geisel had several stipulations for selling the rights to her husband's beloved holiday tale How the Grinch Stole Christmas. Potential buyers had to pay \$5 million and a share of the box office gross, merchandising revenue and other book tie-ins. She also required that "any actor submitted for the Grinch must be of comparable stature to Jack Nicholson, Jim Carrey, Robin Williams and Dustin Hoffman." Luckily, she got her wish when Jim Carrey signed on for the project.

#### 3. Tom Hanks played five characters in 'The Polar Express'.

The actor originally optioned the book hoping to play the conductor and Santa Claus. Later, director Robert Zemeckis considered having him play every role — an incredibly ambitious goal that proved too exhausting for Tom. He ultimately is credited as the hero boy's father, conductor, hobo, Scrooge puppet, Santa Claus and the narrator.

#### 4. 'The Santa Clause' featured real reindeer from the Toronto Zoo.

Filmed in the Greater Toronto area, The Santa Clause relied on the local zoo for casting animal actors capable of playing Santa's sled-pulling team. The trains used in the North Pole scene and the start of the film aren't real locomotives, though. They're actually toy-sized LGB models.
