This tender is to supply the following maintenance services for the RM of Beaver River No. 622 every Saturday, Sunday and all statutory holidays (Friday and Monday holidays only) for the period commencing on May 20, 2023 to September 4, 2023 inclusive:

RM West Boat Launch (NE 12-63-23-W3) / RM East Boat Launch (SE 17-63-22-W3):

Washrooms

- -must be cleaned and bleached daily
- -empty and remove garbage daily (haul to RM waste collection site)
- -refill paper products as required
- -cleaning products and paper products will be supplied by RM
- -monitor septic tank daily and notify RM when pump out is necessary

Fish Filleting Shack

- -must be cleaned and bleached daily
- -cleaning supplies will be supplied by the RM
- -empty and remove garbage daily (haul to RM waste collection site)
- -remove and haul away fish offal daily to RM waste collection site
- -remove garbage or anything that is not fish offal before disposing in designated area.
- -monitor septic tank daily and notify RM when pump out is necessary


Washrooms

GRAVEL HAUL & SPREAD TENDER, 2023

The RM of Beaver River No. 622 hereby invites tenders from qualified contractors in order to award a contract for the hauling and spreading of approximately 20,000 tonnes of road gravel to complete 2023 municipal road maintenance program.

The 2023 gravel program will encompass 2 quarries with hauling/spreading volumes as described below:

♦ RM Pit - N.E. 21-61-25-W3 (Approx. 5 miles South of Pierceland on Highway 21 and 4 miles East on TWP 621 A):

<u>Haul/Spread from Stockpile:</u> Approx. 10,000 tonnes (Hauler responsible for supplying personnel, equipment, and scale for all loading)

◆ RM Pit – N.E. 14-61-21-W3 (Approx. 3.5 miles South of Highway 55 on RR 3212):

<u>Haul/Spread from Stockpile:</u> Approx. 10,000 tonnes (Hauler responsible for supplying personnel, equipment, and scale for all loading)

Please provide quotes based on the assumption that the RM of Beaver River No. 622 will supply personnel for gravel checking.

The Contractor shall furnish all labour and equipment to perform the work as specified herein. Bids must be based on legal road weights. Minimum of 6 trucks, the municipality reserves the right to stop daily hauling operation at such time(s) when 3 or less trucks are available.

The municipality reserves the right to stop hauling operation during periods of inclement weather when, in the opinion of the municipality or gravel checker, the roads are susceptible to structural or surface damage.

We wish to invite tenders from contractors who are capable of completing the contract per the following timeline:

Spring 2023 (dependent upon weather)

Do you <u>own</u> or <u>lease</u> agricultural land in an adjoining municipality? (RM of Meadow Lake #588 or RM of Loon Lake #561)

If so, you may be eligible to receive a municipal tax exemption on your permanent residential dwelling as per section 293 of The Municipalities Act (residential dwelling cannot be located in an organized or unorganized hamlet).

You must fill out the prescribed form called the "Land Owned or Under Lease Agreement in Adjoining Municipalities". It must be completed with the other RM Administrator's Authorization Signature. You must return the form to the RM of Beaver River's office on or before March 31st ANNUALLY to be eligible for this exemption.

This form can be picked up at the RM office or found on our website (www.rmofbeaverriver622.ca) under the Policies & Bylaws tab—General Government—Farmland Exemption Policy.

Do you rent agricultural land within the RM of Beaver River?

If so, and you wish to receive a municipal tax exemption on your permanent residential dwelling (as per Section 293 of The Municipalities Act) you must provide the rental agreement and written notice, signed by the owner, stating that the owner has agreed that the lessee is to receive the exemption. The letter must indicate the land location of the rental property. The rental agreement or letter must be submitted to the RM of Beaver River's office on or before March 31st ANNUALLY to be eligible for this exemption.

Snow Plowing

The RM of Beaver River can be contracted to snow plow your

rural driveway with a grader. Prepaid snow plow flags are available at the RM office for \$40 plus GST. A form must also be completed <u>before</u> grading, authorizing the RM to complete this work. The form is available both at the RM office and on the website under Policies & Bylaws, then click on RM Forms. If you purchase a flag and place it at your driveway entrance the work will be done when the grader is in your area.

Each flag is only good for one grader visit.

Why does snow sometimes sparkle?

Snow sparkle is caused by light reflecting off ice crystals that have settled on top of the snow.

Snow is made of ice crystals, and as a crystal gently falls on a surface, it may lie relatively flat. Some crystals are smooth and can act like mirrors and reflect light. When conditions are right, rays of light hit individual ice crystals that are on the uppermost layer of snow and reflect the light upward, at the angle of reflection. The reflected light will be bright, a small image of the sun or other light source.

For the light ray to hit your eye and become visible, the crystal has to be lying at the correct angle on the surface so the angle of reflection sends the beam your way. Of the thousands of ice crystals lying the surface, you see only those that align correctly. If you move, you encounter different crystals that are also at the correct orientation.

Dry conditions can increase the likelihood of seeing snow sparkles because ice crystals often stay separate in drier conditions. Warmer days decrease the likelihood of seeing snow sparkles because, as the crystals may melt, they merge together and may not lie as a flat reflective surface.
