The RM of Beaver River can be contracted to snow plow your rural driveway with a grader. Prepaid snow plow flags are available at the RM office for \$40 plus GST. A form must also be completed before grading, authorizing the RM to complete this work. The form is available both at the RM office and on the website under Policies & Bylaws, then click on RM Forms. If you purchase a flag and place it at your driveway entrance the work will be done when the grader is in your area.
