Do you <u>own</u> or <u>lease</u> agricultural land in an adjoining municipality?

(RM of Meadow Lake #588 or RM of Loon Lake #561)

If so, you may be eligible to receive a municipal tax exemption on your permanent residential dwelling as per section 293 of The Municipalities Act (residential dwelling cannot be located in an organized or unorganized hamlet).

You must fill out the prescribed form called the "Land Owned or Under Lease Agreement in Adjoining Municipalities". It must be completed with the other RM Administrator's Authorization Signature. You must return the form to the RM of Beaver River's office on or before March 31st ANNUALLY to be eligible for this exemption.

This form can be picked up at the RM office or found on our website (www.rmofbeaverriver622.ca) under the Policies & Bylaws tab—General Government—<u>Farmland Exemption Policy</u>.

Do you rent agricultural land within the RM of Beaver River?

If so, and you wish to receive a municipal tax exemption on your permanent residential dwelling (as per Section 293 of The Municipalities Act) you must provide the rental agreement and written notice, signed by the owner, stating that the owner has agreed that the lessee is to receive the exemption. The letter must indicate the land location of the rental property. The rental agreement or letter must be submitted to the RM of Beaver River's office on or before March 31st ANNUALLY to be eligible for this exemption.

Washrooms

- -must be cleaned and bleached daily
- -empty and remove garbage daily (haul to RM waste collection site)
- -refill paper products as required
- -cleaning products and paper products will be supplied by RM
- -monitor septic tank daily and notify RM when pump out is necessary

Fish Filleting Shack

- -must be cleaned and bleached daily
- -cleaning supplies will be supplied by the RM
- -empty and remove garbage daily (haul to RM waste collection site)
- -remove and haul away fish offal daily to RM waste collection site
- -remove garbage or anything that is not fish offal before disposing in designated area.
- -monitor septic tank daily and notify RM when pump out is necessary

Washrooms

- -must be cleaned and bleached daily
- -empty and remove garbage daily (haul to RM waste collection site)
- -refill paper products as required
- -cleaning products and paper products will be supplied by RM
- -monitor septic tank daily and notify RM when pump out is necessary



Hockey Puck History



The first hockey pucks were made from frozen cow poop. These early pucks had a lifespan of about one game before they were too soft or too hard for playability, so they were replaced with wooden ones.

Square Pucks, made of wood or rubber, were used in hockey's earliest games. The original puck used first in the first organized games in Kingston on March 10, 1886 (on display at the Original Hockey Hall of Fame), was made from a cut down lacrosse ball. It looks like a lump of coal, is made from soft rubber, and bounces far more than a modern hockey puck.

By the 1870s, flat pucks were made of wood as well as rubber. At first, pucks were made in the shape of a square. Records from the first indoor ice hockey game used a wooden puck, to prevent it from leaving the area of play, though new evidence has shown that cuts from large corks have also been used.

Rubber pucks were first made by slicing a rubber ball, then trimming the disk square. The Victoria Hockey Club of Montreal is credited with making and using the first round pucks, in the 1880s.

In the early 1900's pucks were made of layers of rubber that were glued together. In the 1940's pucks made of synthetic rather than natural rubber became standardized. In the 1990-1991 season the NHL began to require regulation hockey pucks for professional games.

The modern hockey puck is 3 inches across and 1 inch high. The puck must weigh between 5.5 and 6 ounces per International Ice Hockey Federation standards.

The modern pucks have textured edges. Diamond texture increases friction between puck and stick for better control.

Pucks are made of vulcanized rubber. Natural rubber can become brittle when cold where vulcanized rubber is more durable.

Angry Voters Once Took to Mailing Hockey Pucks! In 2000, the Canadian Taxpayers' Federation urged the country's citizens to protest their government's \$12 million bailout of domestic NHL franchises. How? By mailing oodles of hockey pucks to then-Prime Minister Jean Chretien. According to group president Walter Robinson, "When the rubber hits the Prime Minister's office in a shower of hockey pucks, Mr. Chretien might have some sense knocked into him and respond." The Prime Minister never revealed how many pucks he'd actually received.

Snow Plowing

The RM of Beaver River can be contracted to snow plow your

rural driveway with a grader. Prepaid snow plow flags are available at the RM office for \$40 plus GST. A form must also be completed <u>before</u> grading, authorizing the RM to complete this work. The form is available both at the RM office and on the website under Policies & Bylaws, then click on RM Forms. If you purchase a flag
