Winter snow plowing takes place with the following priorities:

- 1. School Bus Routes
- 2. Main grid roads
- 3. Other municipal roads

Snow plowing for ratepayer driveways, who have purchased snow flags, will be done after the bus routes and main grid roads are completed. They will be done as time allows during municipal road clearing and at the operators discretion due to the amount of snowfall on the municipal road.

Snow Plowing



The RM of Beaver River can be contracted to snow plow your driveway. Prepaid snow plow flags are available at the RM office for \$40 plus GST. A form must also be filled out authorizing the RM to complete this work. The form is available both at the RM office and on the website under Policies & Bylaws, then click on RM Forms. If you purchase a flag and place it at your driveway entrance the work will be done when the grader is in your area and as time permits.

Each flag is only good for one grader visit.



Stay Safe on the Ice This Winter

With temperatures cooling and snow arriving, the Water Security Agency (WSA) is reminding the public to ensure that ice is thick enough to safely walk, drive or snowmobile on.

Ice thickness can be unpredictable and difficult to assess at times. It does not freeze at a uniform thickness and its strength can vary considerably from one area to another.

To be sure, check the ice thickness before you travel on it. As a guideline, you need at least 10 cm (four inches) of ice to walk on, 20 cm (eight inches) to drive a snowmobile or ATV on, 30 cm (12 inches) to drive a car or light truck on, and more than 30 cm (12 inches) to support a heavy truck.

Guidelines are provided to help individuals decide whether to venture onto the ice. Thickness is just one consideration when evaluating ice safety. Clear, hard ice is the only ice recommended for travel.

You should always check ice conditions where you are before venturing on to the ice.

Ice should be re-evaluated on every date visited, even if it was safe on a previous date. The date that ice becomes safe at a site varies year-over-year requiring the verification of the thickness each year as opposed to relying on past experiences.

Also avoid ice that:

- looks slushy;
- * has thawed, then froze again;
- is near moving water;
- * is layered, caused by sudden temperature changes; or
- has structures on it, such as pressure ridges.

December 28 & 29 - All sites closed


December 30 - Pierceland Transfer Site open 10 am to 4 pm
