Do you <u>own</u> or <u>lease</u> agricultural land in an adjoining municipality?

(RM of Meadow Lake #588 or RM of Loon Lake #561)

If so, you may be eligible to receive a municipal tax exemption on your permanent residential dwelling as per section 293 of The Municipalities Act (residential dwelling cannot be located in an organized or unorganized hamlet).

You must fill out the prescribed form called the "Land Owned or Under Lease Agreement in Adjoining Municipalities". It must be completed with the other RM Administrator's Authorization Signature. You must return the form to the RM of Beaver River's office on or before March 31st ANNUALLY to be eligible for this exemption.

This form can be picked up at the RM office or found on our website (www.rmofbeaverriver622.ca) under the Policies & Bylaws tab—General Government—<u>Farmland Exemption Policy</u>.

### Do you rent agricultural land within the RM of Beaver River?

If so, and you wish to receive a municipal tax exemption on your permanent residential dwelling (as per Section 293 of The Municipalities Act) you must provide the rental agreement and written notice, signed by the owner, stating that the owner has agreed that the lessee is to receive the exemption. The letter must indicate the land location of the rental property. The rental agreement or letter must be submitted to the RM of Beaver River's office on or before March 31st ANNUALLY to be eligible for this exemption.

As the Community Planner you will be responsible for:

### **GRAVEL CRUSHING TENDER, 2024**

The RM of Beaver River No. 622 hereby invites tenders from qualified contractors in order to award a contract for the following:

Crushing of approximately 20,000 cubic yards of 7/8" Road Gravel to complete the RM's 2024 gravel program.

The Contractor shall furnish all labour and equipment to perform the work as specified herein.

Material shall be crushed and piled by the contractor on location at the RM Pit known as the "Goodsoil Pit" located at NE-14-61-21-W3.

Once materials have been stockpiled in the Goodsoil Pit, the stockpile will be surveyed by the Municipality. The Contractor will inform the RM Administrator when nearing 80% completion in order to schedule survey of the pile in a timely manner.

We wish to invite tenders from contractors who are capable of completing the contract per the following timeline:

#### Spring 2024 (dependant upon weather)

The RM shall make payment of the account within thirty (30) days of the survey result. Payment subject to the pit being left in acceptable condition.

The Contractor must provide a Clearance Certificate from Saskatchewan Workers Compensation Board.

The Contractor must provide a Certificate of Insurance for two million dollars in liability insurance.

### **GRAVEL HAUL & SPREAD TENDER, 2024**

The RM of Beaver River No. 622 hereby invites tenders from qualified contractors in order to award a contract for the following:

Hauling and spreading of approximately 20,000 tonnes (+/-) of road gravel to complete 2024 municipal road maintenance program.

The 2024 gravel program will encompass 2 quarries with hauling/spreading volumes as described below:

RM Pit - N.E. 21-61-25-W3 (Approx. 5 miles South of Pierceland on Highway 21 and 4 miles East on TWP 621 A):

Haul/Spread from Stockpile: Approx. 10,000 tonnes (+/-) (Hauler responsible for supplying personnel, equipment, and scale for all loading)

RM Pit – N.E. 14-61-21-W3 (Approx. 3.5 miles South of Highway 55 on RR 3212):

Haul/Spread from Stockpile: Approx. 10,000 tonnes (+/-) (Hauler responsible for supplying personnel, equipment, and scale for all loading)

Please provide quotes based on the assumption that the RM of Beaver River No. 622 will supply personnel for gravel checking.

The Contractor must provide a Clearance Certificate from Saskatchewan Workers Compensation Board.

The Contractor must provide a Certificate of Insurance for two million dollars in liability insurance.

The Contractor shall furnish all labour and equipment to perform the work as specified herein. Bids must be based on legal road weights. Minimum of 6 trucks, the municipality reserves the right to stop daily hauling operation at such time(s) when 3 or less trucks are available.

The RM reserves the right to stop hauling operation during periods of inclement weather when, in the opinion of the municipality or gravel checker, the roads are susceptible to structural or surface damage.



### **Hoar Frost**

Hoar frost is a type of feathery frost that forms as a result of specific climatic conditions. The word 'hoar' comes from old English and refers to the old age appearance of the frost; the way the ice crystals form makes it look like white hair or a beard.

Hoar frost requires slightly different conditions than ground frost. It forms when the water vapour in the air comes into contact with solid surfaces that are already below the freezing point. Ice crystals form immediately, and the ice continues to grow as more water vapour is frozen. On a still night, it can grow well on tree branches, where the surface temperature

The size of the frost that forms depends on how much water vapour is available to 'feed' the ice crystals as they grow. Hoar frost has a distinctive appearance as it forms hair-like or feathery structures as it grows.

is unlikely to rise above zero for several hours.
