2. Only one recreation vehicle to be a permitted use on a lot in Lakeshore Development District.
3. Objection to 21 day time limit for visiting campers. There should be no time limit.
4. Camper age within lakeshore district should be later than 1990.
5. Recommendation that council holds a meeting with lakeshore property owners to discuss recreation vehicles.


