Policy Title:	Adjoining Municipality Farmland Exemption Policy

All farmland land owned or under lease agreement in an applicable adjoining municipality shall be reported using the prescribed form "LAND OWNED OR UNDER LEASE AGREEMENT IN ADJOINING MUNICIPALITIES" (attached and forming part of this policy). This form shall be filled out by the land owner or lessee, complete with the adjoining RM Administrators authorization signature and returned to the RM of Beaver River's Administrator on or before March 31 **annually** to be eligible to receive municipal tax exemption on their residential dwelling as per section 293 of *The Municipalities Act*.

Applicable adjoining municipalities:

- Rural municipality of Meadow Lake #588
- Rural Municipality of Loon Lake #561

****Should the prescribed form be filled out improperly or incomplete no exemption shall be applied.****
