Mail-in Ballot Voting System

Are you unable to attend the November 13, 2024 General Election for the RM of Beaver River? We offer the option for mail-in ballot registration. If you are unable to register for a ballot in person, a voter's registration form and mail-in ballot declaration can be filled in and witnessed by any of the following:

- the returning officer (at the municipal office);
- the deputy returning officer (at the municipal office);

OR

- an enumerator;
- a notary public;
- a commissioner for oaths;
- any other person authorized to sign oaths; or
- a lawyer.

Please ensure you present picture identification to the witness

The actual Mail-in Ballots will be mailed out to you before the election and are to be returned by November 13, 2024 to be counted.

Public Notice - Zoning Bylaw Amendment

Public Notice is hereby given that the Council of the Rural Municipality of Beaver River No. 622 (RM) intends to adopt a bylaw under *The Planning and Development Act, 2007*. Bylaw No 07-24 to amend Bylaw No. 57 known as the Zoning Bylaw (ZB).

INTENT: Proposed Bylaw 07-24 would rezone a proposed residential subdivision from agricultural to LD1 – Lakeshore residential to accommodate for density and site size requirements.

AFFECTED LAND: LOT 4, BLK 1, PLAN 00B01503 & SE-27-62-23-W3M EXT 70 in Northern Meadows will be affected by the proposed bylaws.

REASON: accommodate the proposed subdivision to comply with density and site size requirements.

PUBLIC INSPECTION: Any person may inspect the bylaws at the RM Office during regular business hours, excluding statutory holidays. Hard copies will be available to the public at a cost or by contacting the RM Office and asking for a digital copy.

PUBLIC HEARING: Council will hold a public hearing at **10:15AM** on **November 21st, 2024,** to hear any person or group that wants to comment on the proposed bylaws. Council will also consider written comments received **on or before November 15th, 2024,** by the undersigned at the RM office by hardcopy or email before the hearing. 

BEAVER RIVER **CRIME WATCH**



Rural Crime Watch is a community driven, community led, police supported, crime prevention and reduction collaborative program. The Rural Crime Watch program in Saskatchewan is a partnership between the Saskatchewan Rural Crime Watch Association (SRCWA), local Beaver River Crime Watch, the RCMP, and its authorized Protection and Response Team (PRT). The RCMP's PRT partners include Saskatchewan Conservation Officer Services and Saskatchewan Highway Patrol, Beaver River Crime Watch members are volunteers who serve as the 'Eyes and Ears' of their communities and contact the police to report suspicious activites.

Role of the Members

- · Report all unusual or suspicious vehicles or occurrences immediately to the RCMP or for emergencies: 911.
- · Respond to RCMP fan-out messages.
- · Make an inventory of your property and mark all your valuables with your Driver's License Number.
- Display your Rural Crime Watch signs as soon as you receive them.
- · Attend any information meetings held in your area and take an active part in your

Snowploughing

The Snowploughing of Private Drives and Lanes Policy was amended via Council resolution #227-24 at the September 19th meeting. The changes include:



- Flag fee price increased to \$100.00 per flag (per service).
- Bus routes, primary municipal roads and secondary municipal roads are priority. Driveways may be ploughed only AFTER the aforementioned is complete, as time permits. Furthermore, the property owner acknowledges that on occasion, due to unforeseen circumstances, that their laneway may not be ploughed by the Municipality and that they may be required to make alternative arrangements to have the laneways ploughed.
