Purpose:

- To administer a fair and consistent formal process for transporting of goods on roads within the Rural Municipality of Beaver River No. 622.

Definitions:

“Administrator” means Administrator for the Rural Municipality of Beaver River No. 622.

“Applicant” means the individual(s), company or organization submitting a Road Maintenance Agreement (RMA).

“Bulk Haul” means any single or repeated transportation of goods by, to or for a shipper, hauler or receiver, of divisible or non-divisible loads, over a defined route, that:

- amount to a payload in excess of 2 tonnes; and

In the opinion of the Council responsible for the defined route:

- are significant in nature by haul type, weight, or frequency; and
- may cause damage to streets or roads or cause road maintenance requirements that exceed those of other users of the roads.

“Council” means Council for the Rural Municipality of Beaver River No. 622.

“Goods” means materials or commodities such as but not limited to sand, gravel and timber.

“Hauler” means individuals(s), Company or Organization whom wish to use a Municipal Road for the transportation or delivery of goods within the Municipality.

“Municipality” means the Rural Municipality of Beaver River No. 622.

“Road Maintenance Agreement (RMA)” means a duly signed agreement between a Hauler and the Municipality that outlines the conditions by which the Hauler is permitted to haul goods on specified Municipal roads.

“The Municipality” means the Rural Municipality of Beaver River No. 622.



Scope:

- All RMA's within the Rural Municipality of Beaver River No. 622 shall be conducted in accordance with this policy.

Rates:

- Pursuant to section 12.1 and 12.2 of *The Municipalities Regulations* – North Central Transportation Planning Committee Rates.

Policy:

- As per the discretion of the Administrator, Haulers shall obtain an RMA to authorize bulk hauling activity within the Municipality and requires payment of the provincial hauling fees as per the North Central Transportation Planning Committee rates.

Road Maintenance Agreement (RMA):

- Agreements may be issued twice annually. March 16 – November 14th for summer haul and November 15th – March 15th for winter haul, OR on a haul-by-haul basis.
- Agreements shall be forwarded to the Applicant via the Municipal Administrator, or another Office Staff Member.
- Applicant must complete the required agreement.
- Agreements shall be signed by the Applicant and returned to the Municipal Administrator, or another Office Staff Member prior to the commencement of ANY haul.
- Applicant is subject to any and all conditions as stated in said agreement.
- Following completion of the haul, the Applicant shall pay the prescribed fee as stated within.
