2025 Tax Notices

The 2025 Tax Notices were issued July 29, 2025. If you had an email address on file with us your tax notice was sent by email. Please add rm622@sasktel.net as a safe sender or add us to your contact list and this should prevent it from happening in the future.

If you have not received your Tax Notice by mail yet please give us a call **306-839-2060** and we can check and update your information if necessary then send you a new notice.

The RM of Beaver River offers discounts for early payment of your taxes. This discount only applies to the Municipal portion of the taxes and not the School portion.

The discounts are as follows, if payment received by the end of that month:

- ◆ October 4%
- ◆ November 2%
- ◆ December 0%

PUBLIC NOTICE is hereby given that the Council of the Rural Municipality of Beaver River No. 622 (RM) intends to adopt a bylaw under *The Planning and Development Act*, 2007. **Bylaw 06-25** to amend Bylaw 04-24 which amends Bylaw No. 57 known as the Zoning Bylaw (ZB).

INTENT:

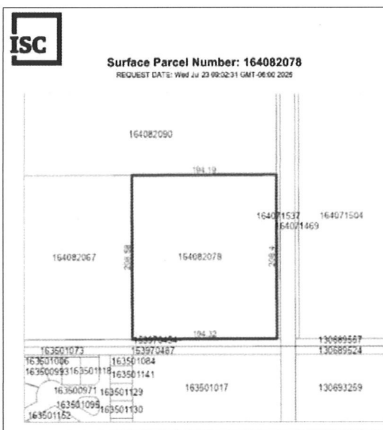
1. The Zoning District Map, referred to in PART IV ZONING DISTRICTS MAP & SUBSECTION 6.3 ZONING DISTRICT BOUNDARIES, is amended by:
 - a) Zoning as A- Agricultural District, all of the lands as described in detail below:
 - a. Rezoning from A – AGRICULTURAL DISTRICT TO C – COMMERCIAL DISTRICT, all of that portion of S.E.¼ SEC.34-TWP.62-RGE.23-W.3Mer., identified as Parcel D, Plan 101945684, and shown in the black outline which is attached to and forms part of this bylaw as Schedule "A".

PUBLIC INSPECTION: Any person may inspect the bylaws at the RM Office during regular business hours, excluding statutory holidays. Hard copies will be available to the public at a cost or by contacting the RM Office and asking for a digital copy.

PUBLIC HEARING: Council will hold a public hearing at **10:30 a.m. on September 16th, 2025**, to hear any person or group that wants to comment on the proposed bylaws. Zoning Bylaw Amendment

PUBLIC NOTICE is hereby given that the Council of the Rural Municipality of Beaver River No. 622 (RM) intends to adopt a bylaw under *The Planning and Development Act*, 2007. Bylaw 05-25 to amend Bylaw 04-24 which amends **Bylaw No. 57** known as the Zoning Bylaw (ZB).

INTENT: Change site area and site frontage

As follows:

1. **Part IV – Schedule E: LD2 – Lakeshore Development 2 District. B. Regulations 1. Site Area Single Detached Dwellings – is amended by changing the Minimum Site Size to the following:**
 - (a) Single Detached Dwellings: Minimum – 750.00 sq. metres (8,073 sq.ft.)
2. **Regulations, 2 Site Frontage (b) Single Detached dwellings, in amended by changing the Minimum Site Frontage to the following:**
 - (a) Single detached dwellings: Minimum – 18 metres (60 ft.)

PUBLIC INSPECTION: Any person may inspect the bylaws at the RM Office during regular business hours, excluding statutory holidays. Hard copies will be available to the public at a cost or by contacting the RM Office and asking for a digital copy.

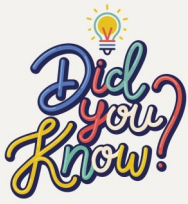
Council and Staff would like to welcome our new Office Clerk

- According to The Weather Channel, pumpkins are the most craved food during the fall. Although, if you've left the house anytime recently, this may not come as a surprise to you.
- The yellow and orange colors you see actually always exist in leaves but they are overpowered by the abundance of green from chlorophyll. The amount of chlorophyll starts to decrease as the sun weakens and the days grow shorter.
- Weight gain around this time of year may not only be due to comforting fall foods like pumpkin pie and cider, researchers have found that lack of vitamin D reduces fat breakdown and triggers fat storage.
- Evergreen trees such as pines, cedars, and spruces stay green because their leaves (needles) are covered with thick wax and they contain materials that prevent freezing when it gets cold.
- According to NASA, autumn is "aurora season" because geomagnetic storms are about twice as frequent as the annual average during the fall.
- A "Harvest Moon" is the full moon closest to the autumn equinox. Before artificial lighting, such moonlight was essential to a farmer's successful harvest.
- According to superstition, catching leaves in autumn brings good luck. Every leaf means a lucky month next year.
